Introducing Dr Priya John, the New GS and CEO

Meet Dr. Priya Letitia John, who took charge as the General Secretary and Chief Executive Officer of Christian Medical Association of India on July 8, 2019. She is the first Indian woman who has assumed this office in the history of CMAI.

Education: After MBBS from CMC, Vellore, she took MD in Community Medicine from St. John's Medical College Bengaluru and later received the Diplomate of the National Board (DNB) in Social and Preventive medicine.

Professional Biography:

Dr Priya has worked in different areas of community health, teaching, palliative care and research. While working at the Bangalore Baptist hospital she managed the community based outreach programme for the hospital. During this time she began a DOTS centre in the main hospital in Bangalore.

When her family moved to Coimbatore she joined the PSG Medical College as an assistant professor. When the family relocated to Delhi she worked as a Palliative care physician in a hospice providing end of life care for terminally ill cancer patients.

In CMAI:

In May 2012, Dr. Priya joined the CMAI as a senior programme coordinator, and later as acting head of Community Health Department. Here she gained valuable experience in administration, project writing, monitoring and evaluation. She was selected as the General Secretary while working as the Senior Coordinator on the Project Management Evaluation and



Learning (PMEL) Desk of CMAI. Dr Priya has represented CMAI at various forums such as GAVI-CSO platform, The Centre for Bio-ethics (TCB) and has also been the Chairperson of the Alliance for Immunisation and Health (AiH).

Dr Priya John comes from a family which has Christian commitment and a passion for healthcare. Her parents Dr. Ragini and Dr. Stanley Macaden have been doctors serving the poor through their work in mission hospitals. Her in-laws Mrs. Lily and Col. John have been involved in the Gideons ministry for decades. Her husband Dr. Suviraj is a renowned surgeon in Delhi and her son Arpit is in class 11 pursuing his studies in science.

DEVOTION

Children are like Flowers; Allow them to Bloom

A family along with their nine-month old daughter was sleeping on the terrace. A 28-year-old drunkard kidnapped the girl child and brutally raped her. By the time they caught the accused and took the child to a hospital, she died.

I struggled to understand why such things happen in this world and started to think on what Bible says about children? How people especially Jesus, treated children?

Almost all interpreters of Matthew's Gospel have considered Chapter 18:1-35 as a literary unit. 18:1 begins the context and 18:35 ends it. Chapter 19 confirms that with the beginning verse "when Jesus had finished saying..." We observe the location (Galilee) and the audience (Pharisees) changed.

But, this pericope is part of a larger teaching unit of Jesus (18:1 - 19:15) in which the people are instructed about 'childlikeness and the kingdom'. This section has references to children as model recipients of the Reign. Each pericope speaks about two kinds of people: "the Vulnerable and the Responsible."

The vulnerable are the children in context and are presented as valuable and worth restoring/protecting. The responsible group is called to restore those who seem to be insignificant, and on whom Jesus places a special value.

At its simplest level, this story tells us that Jesus loves, welcomes and blesses children and so should we. Jesus uses this opportunity to

reiterate one of His oft-repeated points, that is about the Godly concern. To abuse a child's trust is the greatest sin we can ever conceive; to love and protect them is the finest gift we can offer.

Jesus portrays himself as the one who restores and protects the weak and vulnerable. In all the Gospels, we see God's tender heart for children. Jesus wants His listeners to understand the dangers of succumbing to temptation.

Let us understand that children are like flowers and we should allow them to bloom, and not wilt.

CARE India Extends Contract for 40 NMS

CARE India renewed the contract for 40 Nurse Mentor Supervisors (NMS) from June 1, 2019. Twenty NMS were replaced to the remaining modules of the project.

According to NITI Ayog Report 2918 the Maternal Mortality Rate (MMR) in Bihar has recorded the third highest (165 for 1,00,000 live births), next only to Assam (237) and UP (201). The national average of MMR is 130. The infant mortality rate is also higher in Bihar (38 for 1000 live births) compared to the other states.

To address this situation, Bill and Melinda Gates Foundation (BMGF) and CARE India launched a programme in 2015 – AMANAT - meaning “something precious” which aimed at improving maternal and neonatal health outcomes in the government facilities through providing skills and management at the healthcare facilities.

The results of the first phase had been commendable and the next phase AMANAT Jyoti Project started in December 2018. In this the nurse mentor supervisors (NMS) trained nurses in 364 hospitals in Bihar. The orientation was given at CMAI office and skill test was given at Safdarjung Hospital, TNAI Noida, Lady Hardinge Hospital and National Institute of Health and Family Welfare (NIHFW).

The NMS underwent their practical orientation at different Mission Hospitals for one week- Broadwell Christian Hospital, Fatehpur, Christian Hospital



Chhatarpur, MP, Holy Family Hospital, Kurji, Patna, Duncan Hospital, Ruxaul, and SS Hospital, Tripolia, Patna.

The team of NMS arrived in Patna, Bihar in the 1st week of January 2018 and were trained in the Modules by CARE India and Simulations by Pronto International in Patna till February 2nd week.

Currently the NMS have completed the Module 2 of AMANAT Jyoti Project and the Module 3 is currently on going and will be completed by August 2nd week.

Review Meetings: CARE India organized review meetings for the NMS, DRU teams and the State teams after the completion of the Modules. Review meeting after module 2 was held in Patna, from March 13 to 15, 2019. During the meetings the NMS shared their

experiences and gave suggestions for improvement. Periodic Regional review meetings are held in the districts coordinated by the CTEs and DRU team for the NMS to discuss their work.

New Courses for Administrators

The two-year distance education course on "LAWS ON HOSPITAL ADMINISTRATION" is ready to be rolled out. It is under distance mode. The one-year Certificate course has been going on for the last five years. Therefore, we are re-creating the curriculum for a post-graduate diploma course for two years.

This course will equip a hospital administrator to deal with many statutory requirements which are now compulsorily enforced by the government authorities.

We firmly believe that the PG Diploma on "Laws on hospital Administration" with two years duration, if certified by a reputed University, would be recognized respected and would be of great help for our institutions.

The staff of small hospitals face big challenges from rising patient expectations, expanding regulatory requirements and the rapid pace of changing healthcare services.

All candidates must have hospital experience of five years. Basic qualifications: Diploma Nurse or any accredited bachelor's or postgraduate degree.

On the Road to NABH


As a part of the Organizational Development (OD) Process, CMAI and CMC organized a two-day training for 19 hospitals on NABH accreditation basics on July 18 and 19, 2019. The venue was at the CMC Bagayam campus.

Based on the discussions with technical experts early this year, a concept note was shared to ensure a clear understanding of the process. A feasibility study of a software tool in monitoring the NABH process was also submitted. Dr Lallu Joseph and team of the CMC Distance Education Department handled the NABH entry level standards and protocols. Mr Anand Joshua, Executive Director,

Christian Institute of Management introduced the OD Process. Dr Jameela George, Executive Director of Centre for Bio-ethics iterated the establishment of a Clinical Ethics Committee in Hospitals.

CMAI will have a follow-up plan for each hospital for the next three months. The presentation of achievements will be done on November 7, from 9 am to 2 pm at the pre-conference of CMAI's 45th Biennial Conference in Hyderabad.

Popular social media used are Website, Facebook, Instagram, Twitter and Blogs.

Why consider fundraising using online media?

- Maintain repository of Donor information and have a clear donor engagement plan.
- Be authentic, transparent and accountable.

LEGAL ISSUES

Responsibility of Employers in POSH

Several cases of sexual harassment of women at the workplace have been filed in various hospitals. Employers need to attend to these cases in a sensitive manner.

With the enactment of the Sexual Harassment of Women at the Workplace (Prevention, Prohibition and Redressal) POSH Act, 2013 it is important for employers to be equipped and deal with it sensitively. As per law the workplace will be conducive to work productively and to their potential.

After CMAI's webinar on the Act, several questions were raised pertaining to the employers' responsibility.

Coverage of the Act

The Act defines workplace which includes healthcare institutions and NGOs/Trusts apart from other institutions.

The term "employer" is given in very broad terms such as:-

- Government – Head of the department
- Person responsible for the management, supervision and control of the workplace.
- Person discharging contractual obligations with respect to his or her employees.
- Dwelling place or house, a person or a household who employs or benefits from the employment of domestic worker.

The Act has a very broad definition of an employee. An Employee is a

person who

- Works on a regular, temporary, ad hoc or daily basis
- Employed directly or through an agent, including a contractor, with or, without the knowledge of the principal



employer

- Whether for remuneration or not, or working on a voluntary basis or otherwise
- Whether the terms of employment are express or implied and
- Includes a co worker, a contract worker, probationer, trainee, apprentice or called by any other such name.

Role of the Employer

The employer has statutory responsibilities under the law, violations of which could lead to a fine, or the rescinding of registration, if found guilty of violating the law. The role of the employer is as follows

- Pass and display an order appointing an Internal Committee (IC) in notice boards of the institution and departments.
- Organize orientation

programmes for the members of the IC

- Provide necessary facilities to the IC like space for meetings, cupboard for files, secretarial assistance, etc.
- Assist in securing the attendance of respondent and witness before the IC
 - Do not try to reconcile the matter between the parties
 - Keep confidentiality of the case as it is a party to the case
 - Transfer/suspend/grant leave to employees as per the recommendation of the IC.
- Act on the findings and recommendations of the IC within 60 days of the receipt of the recommendations.
- Report of the IC to be mentioned in the Annual Report
- Develop policies against sexual harassment, among other obligations

In Telangana and Mumbai, it is mandatory for institutions to upload the details of their ICs on the websites.

Conclusion

It is imperative that the Act is implemented in all institutions. Providing a safe space for women at the workplace is a constitutional right and needs to be upheld.

Apply Due Diligence while Conducting CEB Courses

Dr Priya John, General Secretary Designate spoke about the role of CMAI as a training and certifying institution and reminded all CEB convenors to apply due diligence while managing CEB courses.

The committee deliberated on the recognition of Allied Health Sciences courses by the Government or university bodies.

The Central Education Board of CMAI met on 29th June 2019 at Stem Cell Center, CMC Bagayam.

CMAI CEB has 16 different committees which run 28 different diploma courses. Dr Shaloo Ipe, CEB Chairperson presided over the meeting in the presence of CMAI General Secretary designate Dr Priya John and 22 members. The convenors presented their reports. Dr Stanley Macaden briefly presented the 'National Fellowship in Palliative Medicine Programme'.

Mr Lyric Abraham, Secretary, AHP Section stressed the need for centralizing CEB records with a common software for 16 committees to streamline CEB activities.

During the meeting, CEB has taken the following resolutions

- A candidate can have maximum of three attempts/paper only and a two-year course should be completed in four years
- The National Fellowship in

Palliative Medicine (NFPMP) and National Fellowship in Palliative Nursing (NFPN) are programmes under CEB, while the management is under Community Health Department of CMAI.

- The Mr Samuel Karunakara Award for DMLT top scorer each year will be based on the MoU.
- In continuation to the

CEB digitization process a decision was taken to install a centralized software to streamline documentation, admission and certificate generation of all 28 courses under 16 committees. This will be done after studying the financial feasibility.

Digitization of CEB Records Completed

The digitization of CEB records in the past seven years has been completed. The software attached to the catalogue was created by Big Data Imaging Services, Chennai, who also scanned the records from all training institutions under CEB. Ms Nimma Shanthini entered

almost 28,000 data into the database software and is now easily retrievable if we query a name of the student, or an institution or a course name under CEB.

The next phase of streamlining of CEB records will be to create a common platform for entering

all data under CEB courses so that there is no need for physical records to be kept at various centres. It will all be managed by the central repository of CMAI.

Mr Lyric Abraham supervised the digitization process and was completed in record time. JV

In 2018, CMAI made a major strategic initiative to deploy 11 young and dynamic executives as Regional Facilitators (RFs) in different regions of CMAI. It was based on CMAI's commitment to facilitate regional activities and to link HQ with its state counterparts. During the General Body meeting on July 5th, Mr

J. Kilong (alias Mangcha), a representative of the RFs said that they have visited 182 of the 272 active member institutions.

Dr Sunita Abraham, head of Community Health Department who supervises the RFs activities, conducted two review meetings in the last one year.

Their work include visiting churches under the National Council of Churches in India (NCCI). The RFs initiated monthly

prayer meetings in a few hospitals. This year many churches have observed "Healing Ministry Week" for the first time. The churches now show interest in participating in CMAI activities.

'institutional facilitators'. As per the RF reports, many hospitals have a dearth of specialists who are willing to serve the rural regions. The RFs also focus on youth involvement in CMAI activities. They conduct student interactions by visiting medical, nursing and theological colleges.

Many institutions have renewed their CMAI membership.

According to Mr Santhosh, RF Tamil Nadu, "Initially there was a lack of knowledge of medical terms and CMAI. Now we understand the vision of CMAI and its mission in the healing ministry."
