# 71st National Conference of Nurses League

The 71st National Conference of the Nurses League, CMAI was conducted virtually from 17th to 19th of November 2020. More than 2000 participants had registered including students, staff and faculty. About 78% of the participants were first-time participants; 66% were students; 35% were student non-members; 75% participants were registered from institutions.

The conference began by 10 am. Mrs. Jancy started the day and handed the day over to the moderator – Mrs. Shimy Mathew, the Secretary of the MIBE, CMAI. The Praise and worship was done by the Bangalore Baptist Hospital team. Mrs. Kamala Benjamin, Faculty of Haggai International shared on the theme: Let us consider! (Hebrews 10:24 – 25) – She spoke on putting the pieces together using three principles – God requires obedience; Growth requires stimulation and Perseverance requires eternal vision.

This was followed by the Inauguration session when Mrs. Manjula Ummareddy, SAO of Champa Christian Hospital and Chairperson of Nurses League welcomed Dr. Jayakumar Daniel, the president of the CMAI, Dr. Priya John, General Secretary of CMAI, Rev. Aruldas, HOD of Chaplaincy dept, CMCH & Editor of CMAI and Mrs. Jancy Johnson, Secretary of the NL, CMAI. She also welcomed the participants.



## Panel Discussion - {Preparedness & Intervention}

She wove out the talk into a beautiful 5 stepped process easing the huge burden the topic seemed to be. This was proceeded by a business session led by Mrs. Manjula Ummareddy, President, Nurses League of CMAI where important decisions were made for the Nurses League and the activities of the previous meeting was discussed. The reports were presented by the Secretary of the Nurses League and the MIBE along with the BNESIB. The members approved it and the obituary of Mrs. Susheela Patros was read.

Dr. Vathsala Sadan, Dean, College of Nursing, CMC Vellore. She spoke about the difficulties they faced as a teaching team and mentioned the challenges and the learning areas during the COVID times. She presented it in three topics – Pandemic lockdown – Hostel life challenges and Changes in theory and practicum completion.

Dr. Priya John, the General Secretary of CMAI acknowledged the work of Mrs. Jancy Johnson as this would be her last AGM before her retirement. Her hard work, networking skills, the art of putting details together and a good role model in balancing home, health and family were points noteworthy to take home and put into practice.

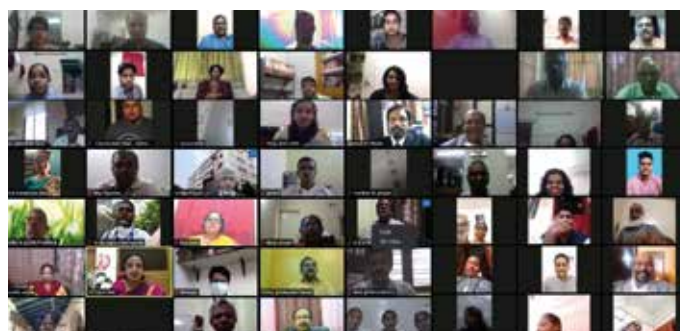

# 13th National Conference of the Chaplains Section

The extraordinary virtual National Conference of the Chaplains Section was held from 24th to 26th November 2020 and had people attending from across the globe. The participants were graced by the presence of Rev. Dr. CB Samuel, Advisor for Micah Global and EFICOR who delivered the Keynote address during the inaugural service. In his words, I quote, "Seeing is the beginning of compassion for chaplaincy as a prophetic ministry. To look for individuals in the crowd having eyes of God. To listen beyond medical history, as Jesus, then start a discussion on kingdom values." The address was thought provoking with plenty of take away lessons for the listeners.

Each session started with 15 minutes of devotion every day led by Rt. Rev. Dr. Royce Manoj Kumar Victor, Bishop of Malabar Diocese took devotion on the first day; Rt. Rev. Dr. Timothy Ravinder, Bishop of Coimbatore Diocese on the second day followed by Rt. Rev. Selvasdas Promoth, Bishop of Bible Faith Mission (BFM) on the final day of conference.

Rev. Dr. JP Sabbithi, Pastor, Joy of Christ Lutheran Church, Hawaiian Islands took up an interesting session on the importance of Clinical Pastoral Education (CPE) in theological education. He stated that "CPE is an avenue to engage in the Healing Ministry of the Church. CPE offer opportunities to seminary students to engage in the healing ministry/bedside theology. It complements (not contradicts) the class room experience with the clinical experience". The session was moderated by Ms. Onenlemla Imsong, Chaplain & Supervisor, Bangalore Baptist Hospital, Bangalore.

The second day had three experts in the field of Clinical Pastoral Education as the panelists, namely, Dr. Sunita Noronha, Dean of Christian Ministry Division, Union Biblical Seminary; Mr. Vilbert Vallance, Chaplains, Bangalore Baptist Hospital, Bangalore, and Dr. Sharon Ruth Israel, Clinical Psychologist, Victoria Hospital/Bangalore Medical College and Research Institute, Bangalore. The topic for discussion was "CPE from the Perspective of Theological Education, Chaplaincy and Clinical Psychology – Way forward." Rev. Paras Tayade, Faculty, Union Biblical Seminary, Pune set the right tone as the moderator of the panel discussion.

During the discussion, Dr. Sunita Noronha stated that "Clinical Pastoral Education is and can be the life blood of holistic theological education. It is to be taken seriously by the Christian community at large. We cannot only rely on the clergy to provide pastoral care. It is undoubtedly, the task of the whole faith community and beyond. A firm and committed resolve is needed to turn this concern into a movement. The purpose is always the care of the people whom God has entrusted to our care." To this, Chaplain Vilbert added, "Chaplaincy is much more than spiritual caregiving."

Rev. Dr. Biju Chacko, Director of Clinical Pastoral Education (CPE) and Neurology Chaplain at the Baptist Health System in Jacksonville, Florida, was the Speaker for the concluding session on the topic "CPE – A Tool for Ministerial Formation". The core of his message was "CPE is an opportunity to understand ministerial formation. It builds competence, reflection and identity. CPE offers a multi-disciplinary learning as we connect with God and connect people to God." Dr. Chacko's knowledge and intelligence on the subject gave more clarity to the audience.

Business session of the section was followed by a special thanksgiving service during which, Ms. Imtinenla Aier, Secretary, Chaplains Section thanked all the participants and resource persons for the fellowship and great time of learning throughout the conference. The three days conference had enlightening Praise and Worship sessions on a daily basis which was led by St. Stephen's Hospital, New Delhi, Bangalore Baptist Hospital and Sungkomen Baptist Church Youth Department. The three days conference Dr. Joseph George, Dean of Doctoral Studies, United Theological College closed the memorable conference with prayer and benediction.

## Stories & Updates

It was a Saturday morning, when 15-years old Matanjy's parents rushed him to Makunda Christian Leprosy and General Hospital not being fully aware of the seriousness of his health. The doctors at the Paediatric ward shared that Matanjy had consumed poison, unknowingly. This came as a shock to his parents blaming themselves terribly when realised that the child had consumed it accidentally, thinking it as a vitamin. However, it was a bottle of insecticide kept inside the vitamin bottle.

They hail from a village close to Meddley in Karimganj district of Assam. Two days later, the relatives brought the bottle which was identified as Paraquat a lethal chemical herbicide. By then Matanjy had already developed clinical manifestations of the poison with a Paraquat tongue in medical literature, renal parameters started climbing up and it appeared as if his liver was also giving up, as he had transaminitis.

The hospital's medical after much research and discussions understood that there was nothing much to offer as an antidote to this substance. The hospital psychiatrist and social worker were beside the family regularly along with the supportive care and within a week's time the renal and the liver parameters slowly normalised. Following which by the second week of watchful expectancy also came to an end. All his body systems began functioning perfectly and Matanjy was discharged miraculously healed.

It was a joy to see Matanjy in the outpatient department as he remains one among the very few survivors of Paraquat ingestion.



## 34th Annual Course on Pastoral Care for the Sick and Suffering

Chaplains Section of Christian Medical Association of India conducted the much awaited 34th Annual Course on Pastoral Care for the Sick and Suffering from October 14th – November 5th, 2020. For this first time the course was offered online using zoom platform where selected candidates met every Monday, Wednesday and Thursday from 02.00 pm to 04.30 pm. A total of 45 participants serving as Pastors, Chaplains, Healthcare professionals, Nurses, Theological students, and Church leaders serving God in the healing ministry registered for the online course. The participants were from across the country including Andaman & Nicobar Islands, Nepal and Canada.

The main objectives of the course were to reaffirm the vision and mission of the church in its healing ministry towards building a just and healthy society and also to equip the People of God to effectively minister to the sick and the suffering giving spiritual care. The course was offered in collaboration with the Indian Association of Palliative Care (IAPC) team. One of the requirements was to complete 16 hours of WHO Curriculum for IAPC Volunteers certification.

Dr. Priya John, the General Secretary of CMAI warmly welcomed the participants at the inaugural ceremony. Rev. Dr. Santanu Patro, Registrar, Senate of Serampore University delivered the inaugural address on the theme

***“Let us Consider...” encouraging participants of the need of the training especially in a time when health and wholeness is much required.***

The resource persons were Dr. Stanley C Macaden, Dr. Ravi Livingstone, Dr. Amy, Sr. Sabitha, Sr. Honey, Mrs. Prameela, Dr. Jenifer Jeba, Sr. Shakila, Dr. Reena George, Dr. Naveen, Dr. Joseph George, Dr. Sunita Abraham, Mr. Sentilong Ozukum, Dr. Rohan Ramesh, Dr. Susithra, and Dr. Shanthi from CMAI member institutions.

Dr. Joseph George, Professor at The United Theological College, Bangalore in his session brought out the importance of understanding the context of the counselee where he stated “The person (counselee) is the product of the environment: socio-cultural, economic, family, education-employment, religious, and other factors that are influential.”

Dr. Stanley C Macaden, National Coordinator of Palliative Care Programme of CMAI gave an overview of Palliative Care and its urgent need in today's context. He brought out the aspects of ‘Palliative Care Service’ from a rural and urban perspective. He defined Palliative care as “Wholistic care, of people facing a ‘life limiting’ illness, to improve their quality of life and death and help their families to cope.”

Topics covered were – Teamwork & Partnership, Family Genogram, Role of Church volunteers, Life limiting conditions, Communication Issues, Providing Spiritual Support - Congregation in healing, Palliative care - Nursing issues, Care of the Elderly, Death & Dying, Ministry to the bereaved, and Pastor's role in Healing Ministry – Community based. The participants were required to present a case study and to submit a reading report for the certification of the course.

## The Bigger role of an Allied Health Professional

In this unprecedented time of Pandemic, our Nation's focus is on the healthcare system of India.

We are talking a lot about the system and how well we can contain this pandemic with vaccines and other preventive measures.

For the 1.3 billion people in India, it's proven that we cannot cater the needs with the existing doctor and nurse population. As of 2014, there were 1.79 million registered nurses/midwives and 786,796 auxiliary nurse midwives in India, according to INC data and 1.8 million registered medical graduates as per MCI.

Nationally representative cross-section household survey and review of published documents by the Central Bureau of Health Intelligence based study published in NCBI says:

***Distribution and qualification of health professionals are serious problems in India when compared with the overall size of the health workers. Policy should focus on enhancing the quality of health workers and mainstreaming professionally qualified persons into the health workforce.***

Here comes the role of Allied health Professionals in our country, this category is neglected till date.

The long pending allied health professional bill 2018 in parliament is the proof for that, there is no central regulatory body for AHP in our country.

Public Health Foundation of India (PHFI). Report of this seminal study -- From Paramedics to Allied Health Services -- which was published in 2012, defined AHPs' role as:

***“Individuals who are involved with the delivery of health or healthcare related services, with qualification and competence in therapeutic, diagnostic, curative, preventive and/or rehabilitative interventions. They could work in interdisciplinary health teams in varied healthcare setting that include doctors, nurses and public health professionals to promote, protect, treat and/or manage a person's physical, mental, social, emotional, environmental health and holistic well-being.”***

In other words, AHPs services are mainly focused on keeping people 'healthy' rather than 'fixing ill-health'. Latter remains in the hands of doctors and nurses.

The focus should be on Preventive Services with well-trained Allied Health professionals. If we can create a robust system for preventive services, then we can reduce the burden of doctors and nurses to great extent. CMAI is a pioneer in Allied health Education in India, our laboratory certificate course started in 1927 at Arogyavaram Medical Centre, Madanapally. Currently CMAI have 30 different Allied health professional Diploma courses in around 60 training Institute across India under our Central Education Board.

***What we need is the support from different state and central Government, so that we can contribute more to cater the health care needs of our country.***

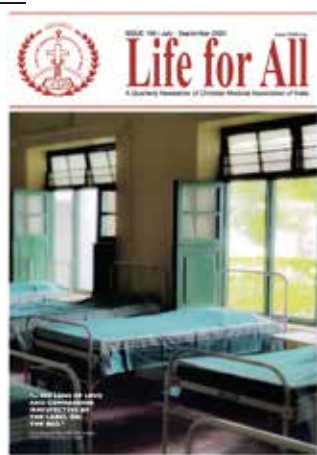
