“First Combined National Conference: Interactive, Inclusive and a New Excitement

Investment in people and relationships will definitely add to the growth. Government policies add value and restrictions in equal measure for healthcare service delivery. Finances for capital expenditure is becoming harder to get and project funding requires a keen understanding of community needs.

This followed by alignment of services both to the need as well as the mission of the hospital. The region specific epidemiology of diseases and therefore, effective interventions, is not easy. It is time, staff and cost intensive. **However, the importance of a community based service, is becoming clearer and clearer in the post pandemic phase.** Supporting our hospitals to take on these services which include mentalhealth, palliative care, geriatric care, counselling, and basic preventive medicine is necessary.

CMAI called for proposals from our mission hospitals to encourage this line of thinking and

we received almost 80 proposals. The process of vetting each proposal, discussing with the concerned hospital and finding donors is the next step. The church support and proactiveness will be crucial in this area. Governance of the hospitals is either a big barrier to sustainability of the hospital or a significant support. Many factors influence this aspect and this is where collective prayer support and constantly seeking His leading are the best solutions.


In future, CMAI and CGE may collaborate to provide a global footprint for the CMAI members and CMAI institutions with a network of key universities in at least 80 nations.

THE POWER OF FORGIVENESS IN THE PATIENT-DOCTOR RELATIONSHIP IN THE GOOGLE ERA (COL 3:13)

In today's digital age, where patients have online access to a variety of information about their symptoms and treatment options, the power of forgiveness in the patient-doctor relationship assumes a new dimension. Since the introduction of search engines and online discussion boards, more and more patients are using the internet to identify and cure their problems before seeing a doctor. As a result of this trend, several patients approach their doctor with predetermined beliefs about their diagnosis and course of treatment, which can provide a variety of difficulties for the doctor-patient relationship. They might have less faith in the doctor's knowledge and therefore be more hesitant to follow his advice. If their web research makes them think that the doctor's diagnosis or treatment plan is flawed, patients may in certain situations even feel resentment against the doctor.

However, overcoming these obstacles may need a significant amount of forgiveness. The patient's trust can be restored, and a more positive and fruitful relationship can be established when a doctor acknowledges any errors they may have made and offers their sincere apologies. Additionally, the doctor can assist the patient in comprehending the limitations of online research and the significance of expert medical counsel by taking the time to comprehend the patient's worries and explaining the logic behind the diagnosis and treatment plan.

Furthermore, when people present to the doctor with a self-diagnosis, forgiveness can aid the physician in resolving any potential ethical conflicts that might develop. Forgiveness can make it easier for a doctor to act compassionately and empathetically in situations where a patient requests a certain treatment that the doctor feels may not be appropriate for the patient. The doctor can assist the patient in choosing their course of therapy by outlining their thinking and encouraging them to get a second opinion.

In conclusion, in today's digital age, the power of forgiveness in the patient-doctor connection is more crucial than ever. It is vital for doctors to comprehend the potential difficulties that this trend can generate as patients increasingly turn to the internet for medical information, and to use forgiveness as a tool to

negotiate these difficulties. Doctors may help to restore trust and build a more rewarding and fruitful relationship with their patients by being open, sympathetic, and empathetic.

When Jesus hung on the Cross, He said 'Father, forgive them; for they do not know what they are doing.' And they cast lots to divide his clothing" - Luke 23:34. If Jesus forgave our sins - sins that we committed in ignorance or deliberately, we as disciples of Christ can pave the way in the medical world and be an example to those around us, by our gentleness and willingness to go the extra mile and help the patient in receiving the best medical care possible.




